

## NYLPI and Kasowitz, Benson, Torres & Friedman LLP Win Compensation for Young Person with Learning Disabilities

NYLPI and **Kasowitz, Benson, Torres & Friedman LLP** won a significant compensatory award from the New York City Department of Education on behalf of Alexander James, a young man with learning disabilities. He will now be able to obtain the educational support he needs to graduate with a high school diploma.

Cheryl James, Alexander's mother, spent four frustrating years trying to get the

Department of Education (DOE) to listen to her pleas. Her son was struggling with his disability and failing in school. His negative experiences had taught him to fear academic environments, further impairing his education. The DOE's specialists diagnosed him as mentally retarded, claiming Alexander was not capable of advancing in an academic setting. Ms. James knew otherwise, but could not convince the bureaucracy.

"Nobody believed me," she recalled. "I just went running around in circles...running to the school, on the phone, going to meetings."

After years of frustration, Ms. James finally connected with Pamela Hux-Singh, a special education advocate, and Kim Sweet, NYLPI Associate General Counsel and Coordinator of the Education Program. Sweet and Hux-Singh helped Ms. James build a case that Alexander could succeed academically with the intensive support of a residential school. They had him evaluated by a group of independent experts who agreed with that assessment.

## Pro Bono Models: Bingham McCutchen Partners with Say Yes to Education to Support Harlem Families

*Pro Bono Models will be a regular series highlighting the innovative pro bono efforts of our member law firms.*

**Bingham McCutchen LLP** has made a commitment virtually unheard-of in the *pro bono* field: they have agreed to provide over 425 families with free legal services for the next fifteen years.

The firm has partnered with Say Yes to Education, a nonprofit academic intervention program for students who are facing educational and social challenges. The organization, which was founded in 1987 by Hartford financial manager George A. Weiss, adopts entire classes of children and provides them and their families with support to help the students graduate from high

school. Say Yes also provides students who graduate with full college tuition at the institution of their choice.

In New York, Say Yes is working with 425 students from five Harlem schools, and Bingham has committed to providing them and their families with *pro bono* legal ser-

VICES for the next 15 years. These services are comprehensive, including assistance with housing and financial issues, educational needs, immigration questions, criminal matters, and estate planning.

Twice a week, Bingham attorneys travel to Harlem for open "office hours" at the schools. Clients are welcome to drop in and discuss their issues with the attorneys present, who either work directly to resolve the problem or refer them to other attorneys if necessary. In addition, the program operates a 24-hour message line, where clients can leave voicemails for urgent situations.

"By providing comprehensive legal services to some of the City's most indigent residents, we are allowing hundreds of children and their families to remain focused on the child's education," said Jaimie Dockray, Managing Director of Bingham's Say Yes to Education Program.

Since November 2004, when the program kicked off, Bingham has provided services on a range of matters, from preventing the

eviction of a mother with two children whose landlord wanted to increase their rent illegally to aiding twenty families in their quest to legalize their immigration status in the United States.

"This is a rare instance where a law firm can work with a significant client to improve the lives of hundreds of people, while bringing a lot of joy to the individual lawyers and staff who are participating in the project," stated Ed Maluf, Bingham partner.

The firm's interest in the families extends beyond the provision of legal services. Last summer, a group of non-legal staff from Bingham worked at a summer camp program run by Say Yes. The experience was enormously rewarding for all the participants, and further affirmed Bingham's commitment to the students and families.

"They're as committed [to the families] as we are," commented Rachel Flax, Say Yes' Regional Director. "Bingham is setting an example for law firms everywhere."

Carter, partner at Dorsey & Whitney LLP. The event was held at Cipriani's and was attended by 700 attorneys.

Prior to joining his current firm, Mr. Carter served as U.S. Attorney for the Eastern District of New York for six years. ## Associate Matters

### Amy Impellizzeri

Amy Impellizzeri, an associate at **Skadden, Arps, Slate, Meagher & Flom LLP**, was looking for a *pro bono* opportunity to sink her teeth into when she learned about NYLPI's special education practice. She heard of a case involving a young girl who had been exhibiting behavioral issues in school. The Department of Education intended to place her in a school for children with disabilities, a decision vigorously opposed by the child's mother. Amy decided to take up the child's cause.

Ultimately, the child and her family prevailed in the matter, and she was able to remain within an integrated setting, with supports set up to address her special needs. Impellizzeri was hooked and decided that she wanted special education to be the focus of her *pro bono* work. She's since taken on two additional

cases in the last two years and looks forward to more.

Impellizzeri enjoys many parts of her special education work, but one of its most inspiring aspects has been working directly with parents. "The parents I've dealt with are incredible," she said. "They're so involved, they sincerely want to navigate the system, and they just need someone to help them do it. They're such amazing advocates for their children."

She also acknowledges that this work comes with some unique challenges. "Usually, when I'm dealing with my corporate clients, there's not the emotional component that's present in my special ed cases," she remarked. But developing those relationships with her clients came with rewards, as well.

"Once [the parents] saw that they could trust me, and that I was here to help, they were much more cooperative," Amy noted. "That's how you get good results."

"Amy is amazingly organized, committed, and compassionate," remarked Kim Sweet,

NYLPI Associate General Counsel and Coordinator of the Education Program. "I knew from the moment I met her that she would do wonderful work for our clients."

On her end, Impellizzeri greatly appreciates the support she has received from NYLPI's in-house staff. "The cooperative relationship among the *pro bono* counsel, the parents, and NYLPI, Kim Sweet in particular, has always been what leads to a successful result."

"We're very proud of the work Amy has done in her special education cases. Her dedication to the work is noteworthy, all the more so because all three of her cases have ended successfully," noted Ron Tabak, Skadden's Special Counsel responsible for its *pro bono* program.

Hux-Singh found Alexander a residential school where he would receive the services he needed and, with NYLPI's guidance, successfully advocated for the DOE to pay his tuition. He flourished at the new school, and is on track to graduate by the end of the 2008 academic year.

Kasowitz attorney Albert Shemmy Mishaan entered the picture as Alexander approached his twenty-first birthday. He was already nineteen when he was placed at the school, and the DOE normally would not have had an obligation to fund his tuition after he reached adulthood. If Alexander was not allowed to continue at his residential school, all the progress he had made would not result in a diploma.

At an impartial hearing, Mishaan argued that after years of failing to meet its obligations to Alexander, the DOE had a responsibility to continue supporting his education. The hearing officer agreed, handing down a resounding decision ordering the City to fund his tuition for up to three more years, which would allow him to graduate.

"I felt a sense of relief," recalled Mishaan. "I was very gratified for the family that the

opinion was strong...it sent a message that they were right, that they had been wronged by the system."

Mishaan also noted that, "Alexander already had a great team around him. His mother has always been a strong advocate for him throughout his life, and Alexander himself is a great guy. I can't emphasize enough how much of a collaborative effort this was."

Ms. James had enthusiastic words for the support that Kasowitz, NYLPI, and Ms. Hux-Singh provided for her.

"Every mother who is battling the Department of Education needs this team," she said.

She is also overjoyed at the progress Alexander has made. "For the first time my son said to me, 'Mother, I'm studying.' I've never heard him say that before."

# Spotlight On: Parents for Inclusive Education

Parents for Inclusive Education (PIE), an organization that NYLPI helped form in 1997 is a group of parents, educators, and advocates working together to make inclusion of children with disabilities a reality in New York City’s schools.

PIE works to ensure that children with disabilities have access to age-appropriate, general education classes, with supports built in to address their special needs. Since its inception, PIE has provided support for over 180 parents, educators and advocates on the issue of inclusion, as well as organized public education campaigns and worked with government officials on systemic reform.



The organization has been a tremendous source of support to parents of children with special needs. “Meeting strangers and talking about their children [who are going through inclusion] is okay, but when you actually know the person, and see how happy and successful their child is, that makes a big difference,” remarked Deborah Cataldo, a PIE member.

In addition, PIE has helped give parents a voice in shaping public policy. One of its

major projects has been to increase parents’ access to information about their rights and options. To that end, they persuaded the City to organize orientation sessions and school tours for parents with children with special needs who are entering kindergarten.

Kim Sweet, NYLPI Associate General Counsel and Coordinator of the Education Program, was one of the founders of the organization, and currently serves as its counsel. “What has kept PIE together is our

shared commitment to the civil rights of children with disabilities. The group attracts parents, advocates, and educators who are willing to push the envelope and take risks to promote a more inclusive society,” said Sweet.

PIE has helped countless parents to empower themselves to become advocates. “PIE helped me through making my decisions, and I want to give back,” said Nora Cohen, a member. “Being involved in PIE gives me the chance to do that.”

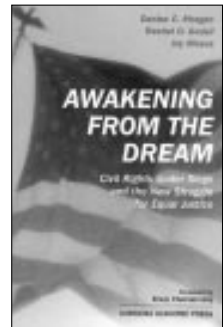
## Campaign Launches Book on Dismantling of Civil Rights

The National Campaign to Restore Civil Rights which is housed at NYLPI, has just released, the highly anticipated book, *Awakening from the Dream: Civil Rights under Siege and the New Struggle for Equal Justice*.

The book exposes the Supreme Court’s methodical dismantling of federal laws that advance inclusion, equal membership, political participation, and economic mobility in the United States. The ongoing Federalism

Revolution has crippled Congress’ legislative powers and made it difficult for individuals to enforce their civil rights in the courts. Law professors, public interest lawyers, students, and activists discuss some of the Americans who have been deprived of justice by this rollback, starkly portraying the impact of the increasingly right-wing federal judiciary.

HERE Arts Center was in a bit of a tough spot when Joshua Schwartz of **O'Melveny & Myers LLP** picked up their case. The organization, which runs an arts collective and exhibition space, was in the midst of an eviction proceeding that their landlord had initiated while waiting for the resolution of a five-year lease renewal.

In addition, the building where the organization was located was about to be sold to a developer, and HERE was to become part of the ownership group that would take possession of the property.

The attorney would have to advocate fiercely on behalf of HERE, while not upsetting the purchase negotiations. Needless to say, the circumstances were fairly tricky, but Schwartz plunged in without hesitation.

Schwartz, along with O'Melveny associates Bingna Guo and Frank Goldman, worked closely with HERE and **Paul Weiss Rifkind Wharton & Garrison LLP**, which represented the organization in their negotiations with the developer. "He was fantastic, really knowledgeable and experienced, and helped us figure out an effective strategy," said Kristin Marting, HERE's Executive Director.

Thanks to the advocacy of both firms, HERE successfully negotiated renewal of their lease and eventually was able to purchase their space.

Working on the matter proved to be rewarding in a number of ways for Schwartz. While he came to the table armed with confidence and expertise, the HERE matter presented him with an opportunity to take the lead role on resolving a complex situation.

"It was great to be able to roll up my sleeves and take full command of the case," Josh recalled.

Josh also had high praise for HERE. "Kristin Marting, in addition to her creative expertise and vision, is also a very compe-

tent manager. [HERE] was a very sophisticated client." In fact, he was so impressed with the group that in June 2005, Josh officially agreed to join HERE's Board of Directors.

Kristin Marting noted, "Josh really got the mission of the organization, and during the course of working on the matter, he displayed a lot of interest. He seemed really enthusiastic about what we were doing, and it seemed like a great fit."

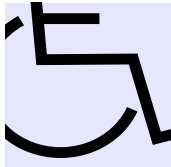
# In-House Update

## The Disability Law Center

NYLPI remains committed to our efforts to protect and promote the civil rights of people with disabilities. In order to balance our programs and improve the performance of all our staff, we have reorganized the Disability Law Center into three program areas: De-institutionalization, Opportunity & Access, and Education.

### De-institutionalization (Roberta Mueller, Coordinator)

**The Placement of Children in Foster Care in Nursing Homes:** The New York City Administration for Children's Services (ACS) just completed a draft policy that would severely restrict placements of foster children in nursing facilities. ACS developed this policy in response to NYLPI's complaints about the inappropriate placement of foster children in nursing homes. Although the current draft represents a major achievement, NYLPI will have ongoing discussions with ACS to ensure that the final policy sufficiently protects children in the foster care system.



**Eligibility for Services for People with Developmental Disabilities:** NYLPI has been negotiating with the New York State Office of Mental Retardation and Developmental Disabilities to alter its eligibility requirements for individuals seeking services. The negotiations reached a milestone in October when OMRDD held a series of statewide trainings for its staff and the staff of voluntary agencies, which will help them better advocate for consumers seeking services. We have also taken on the cases of several consumers who have been turned down for services.

**Coler/Goldwater, a Health & Hospitals Corporation Facility:** NYLPI continues to work on improving the nursing home's policies. We seek to ensure that residents have appropriate access to fresh air, and that all individuals with developmental disabilities are evaluated appropriately and that they, and their families, are given information about services and residential options. NYLPI was also able to help three adult residents to secure services and placement in community-based settings.

**Rutland Nursing Home:** NYLPI is working with Rutland Nursing Home to ensure that the

rights of Rutland's residents are adequately enforced. When we first visited the facility last February, residents had very little access to the outdoors. The nursing home has made some improvements in this area, and we continue to work with them to better their policies and practices.

### Opportunity & Access (Dennis Boyd, Coordinator)

**DIA v. Duane Reade:** Four years ago, NYLPI and co-counsel filed suit against Duane Reade on behalf of Disabled in Action and individuals with mobility impairments against Duane Reade, to address the chain's failure to ensure that their stores comply with the Americans with Disabilities Act. In October 2005, the court issued an order resolving the outstanding issues in the case. The order calls for a settlement by consent decree, sets terms for ensuring that stock that blocks the aisles is removed in a timely way, and clears the way for the terms of the agreement to be made public.

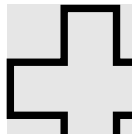
### Education (Kim Sweet, Coordinator)

**Training:** The Learning Disabilities Association of New York State has contracted with NYLPI to train caseworkers in New York City on the educational rights of youth with disabilities who are re-entering the community after placement in juvenile justice facilities. The training program consists of two two-day sessions, the first of which took place in December 2005.

### Access to Health Care (Amanda Masters, Coordinator)

**Disinvestment in New York's Low-Income Communities of Color:** October 2005 was a tumultuous time for residents of Central Brooklyn, who witnessed the loss of a hospital that had been a part of their community for more than a century. NYLPI worked with neighborhood residents to ensure the survival of five outpatient clinics, which were transferred to Kingsbrook Jewish Medical Center. After the closure, The Committee to Save Our Hospital, a local advocacy coalition, convened a forum to provide information to residents on the status of health care in their community.



The Committee is organizing against future hospital closures by collaborating with other medically underserved communities. NYLPI has begun working with residents of Southeast

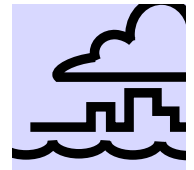
Queens, where Mary Immaculate Hospital is facing possible closure.

**Language Access:** In November 2005, NYLPI and our allies, including the New York Immigration Coalition (NYIC), concluded a successful campaign to expand language access services at New York-Presbyterian/Columbia University Medical Center. The hospital has implemented a range of significant reforms that will provide increased language services for people who are limited English proficient.

On a broader policy level, NYLPI and NYIC have engaged in discussions with city and state officials to ensure improved language assistance services at all New York hospitals. In addition, NYLPI has provided numerous examples of inadequate services at hospitals in the Medisys network, including Jamaica, Brookdale, and Flushing Hospitals, to aid the Attorney General's investigation of language services in the network.

### Environmental Justice (Veronica Eady, Coordinator)

**Bronx Voices for Equal Inclusion:** NYLPI is assisting several community groups in the creation of a community benefits agreement with the developer of a proposed major retail center to be located at the Bronx Terminal Market. The community wishes to ensure that the developer, and any businesses in the space, commit to hiring local residents and paying living wages. NYLPI is working to ensure that the community benefits agreement is legally enforceable, and provides for adequate oversight.



**Concerned Residents Organization:** The Concerned Residents Organization in Soundview continues to raise questions about contamination on the former site of Loral Electronics Systems, where a public high school, is now located. NYLPI is working to ensure that community voices are heard during any discussion about the future of the property. Also, we have been working closely with city officials to ensure that current uses of the property comply with environmental regulations, and are meeting with potential purchasers of the site.
