

## Community Fights to Keep Hospitals Open

NYLPI's Access to Health Care team has been hard at work on a new campaign fighting the closure of hospitals in Central Brooklyn, which is a federally-designated medically underserved area. Central Brooklyn has high rates of AIDS, diabetes, infant mortality, and other health problems exacerbated by previous hospital closures, and new closures would further degrade the area's limited healthcare access. "The percentage of hospitals Central Brooklyn has lost is huge," said NYLPI Senior Staff Attorney Amanda Masters.

In late May, the board of directors of St. Vincent Catholic Medical Centers directed St. Mary's, which it owns, to submit closure plans to the state Health Department. According to recent reports, St. Mary's recorded more than 29,000 outpatient visits and almost 9,300 inpatient visits in the last year (Shelby, Joyce. "Plan to Shut Hosp Ripped." *New York Daily News*: 7 June 2005).

NYLPI Community Organizer Anthony Feliciano helped facilitate a coalition, the Committee to Save Our Hospitals, to work on

these issues. The group met with the CEOs of Kingsbrook Jewish, St. Mary's, and

Interfaith hospitals and has been advocating for strategies to keep healthcare available in the neighborhood.

A New York State commission will convene this year to discuss hospital closures across the state, and the Committee is hoping to have a representative on that commission.

NYLPI has brought suit against the Dept. of Health to stop the state from approving St. Mary's closure. Hospital officials have agreed to consult with community groups about closure decisions, and the Committee is pushing for a discussion of options. The Committee's successful advocacy has led to an high level of community involvement, but the prognosis remains uncertain for the neighborhood's access to quality health care.

## Team Continues Work on Adult Homes Case

This summer discovery will wrap up in a case that challenges the use of adult homes as residences for people with mental illness. Two years ago, in the summer of 2003, a group of disability rights groups including NYLPI, Disability Advocates, Inc., The Bazelon

Center, MFY Legal Services, and the Urban Justice Center, along with co-counsel **Paul, Weiss, Rifkind, Wharton & Garrison** filed suit against Governor Pataki and other New York State officials on behalf of approximately 4,000 people with mental illness residing in large adult homes in New York.

The legal team, including Paul Weiss partner Jeh Johnson and associates Andrew Gordon, Josh Groban, Amelia Cottrell, Beth Frank, Tania Brief, Carrie Gombos, and Francine Murray, has been hard at work since then.

The lawsuit, filed under the Americans with Disabilities Act (ADA) and other statutes, alleges that people with mental illness are being unlawfully segregated in adult homes. The lawsuit contends that these adult homes are large, institutional settings that isolate residents from the rest of the community. Further, the adult homes provide residents

with little or no opportunity to hold jobs, maintain their own finances, or cook their own meals. In addition, there have been repeated instances of abuse of residents by adult home employees. The squalor and chaos of the homes was captured in a Pulitzer Prize-winning exposé written by Clifford Levy in *The New York Times* in 2002, calling public attention to this systemic problem.

The courts have interpreted the ADA to say that the state is obligated to place people in

the least restrictive setting that meets their needs. This lawsuit asserts that many residents of adult homes would be better suited to integrated, community-based housing, which is already available in New York.

Josh Groban of Paul Weiss comments, "This case represents the best kind of collaboration between a law firm and nonprofit organizations in an effort to give a voice to those who, without us, would have no one else to turn to." Stay tuned for updates on this important work!

**Yolanda Garcia**  
*Bronx Community Advocate*  
*(1952-2005)*

Yolanda Garcia, founder and executive director of the We Stay/Nos Quedamos Committee, died of a heart attack on February 17, 2005, at the age of 53. Yolanda was a visionary community planner-developer, and a pioneer in New York City's environmental justice movement. She led the internationally-recognized fight to rebuild the 60+ blocks of vacant lots in the Melrose area of the South Bronx from 1993 until her death.

Yolanda helped form the Nos Quedamos Committee in 1993 to resist large scale urban renewal plans that would have displaced thousands of residents in the Melrose section of the South Bronx. For several years, led by Yolanda, Nos Quedamos embarked on an intense, weekly series of open community meetings with city officials and politicians to successfully force wholesale revisions to the original plan.

Since then, Yolanda turned the organization into a major force for advocacy and communi-

ty revitalization in Melrose and the Bronx as a whole. Nos Quedamos and its partners have created hundreds of units of housing for seniors, families, and new homeowners, rebuilding entire blocks of abandoned, city-owned land with new, owner-occupied townhouses and multi-family apartments — a total of well over a million square feet.

Yolanda was also a leader in the South Bronx environmental justice movement, losing a son to asthma and struggling mightily to spare other families such tragedies. Yolanda helped co-found the Organization of Waterfront Neighborhoods (OWN) and Communities United for Responsible Energy (CURE). Yolanda is missed, but her legacy and warrior spirit, which inspired a generation of environmental justice activists, lives on.

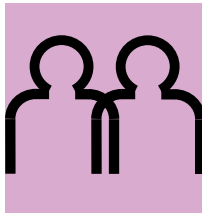
## Associate Matters

children who are applying for permanent housing. Once a month, Heller Ehrman holds a legal clinic at Icahn House. Lenor has been involved in many parts of this program, from recruiting and training volunteers, to interviewing clients at intake clinics, to representing clients at hearings and in state court.

For the past two years, Lenor, along with fellow Heller Ehrman associate Aliya Haider, has run the Heller Ehrman chapter of the Explorers program. Every two weeks during the spring, students from a cross-section of New York City high schools visit the firm’s offices to meet with in-house and guest attorneys for discussions about the law and pursuing a legal career.

Finally, Lenor serves on the firm’s *Pro Bono* Committee. As Bruce Saber, Heller Ehrman’s *Pro Bono* Coordinator, observed, “Lenor’s work on behalf of children with special educational needs reflects a commitment to *pro bono* service that many of us aspire to and few of us attain.”

# Website Launched for Civil Rights Campaign

The National Campaign to Restore Civil Rights, housed at NYLPI, announces the launch of its website.

The Campaign is a nationwide collaboration of organizations and individuals working together to address the rollback of civil rights in the federal courts. The organization links individuals and groups working on a variety of issues, including women’s rights, racial justice, disability rights, environmental justice, language rights, and workers’ rights. The Campaign focuses on public education and outreach, finding ways to spread the word about the impact of recent court rulings on local communities, as well as the erosion of our civil rights nationally.

The site is divided into four main areas:

The **Issues Area** of the website houses fact sheets and information, as well as an active calendar section that links to events that are happening around the country. The news section links to relevant articles

in major national press, as well as local publications. A live feed from partner organizations, including the Leadership Council on Civil Rights, keeps this section up-to-date.

The **Speakers Bureau** is a list of people across the country available to speak about a range of civil rights issues.

The **Resources Area** contains a regularly updated and growing library of resources available to the public, including documents, toolkits, and other materials.

The **Video Area** has three clips from the “Save the Courts.” This video exposes the negative consequences of recent court decisions. Web users can request a free copy of the film, now available with Spanish subtitles.

# NATIONAL CAMPAIGN TO RESTORE CIVIL RIGHTS

## On the Record NYLPI in the News

Much of NYLPI's exceptional work is covered in the local and national media. We will bring the highlights to you from time to time in this new column.

### Disability Rights

#### "Bad Situation Made Worse?"

NYLPI's work to improve police interactions with underrepresented communities, particularly people with disabilities, was highlighted by **Newsday** on March 28, 2005. Senior Staff Attorney Amanda Masters has worked for years on behalf of the mother of a man with schizophrenia who was shot and killed by police officers in a precinct house in Queens in 1998. The lawsuit, filed in 1999, aims to improve the NYPD's out dated policies with respect to encounters with people with mental illness. "This is a challenge to the city for their policies and training around this issue," Amanda is quoted as saying. "The city has been unwilling to change the patrol guide policy, which remains the same as in 1985."

#### "Racial Disproportion Seen In Applying Kendra's Law"

On April 7, 2005, **The New York Times** reported that John Gresham, Senior Litigation Counsel at NYLPI, testified before the City Council on findings of a recent examination of state data that shows that black New Yorkers are nearly five times as likely as whites to be the subject of court orders stemming from "Kendra's Law." The law gives judges the power to force people with mental illness to comply with treatment. John commented, "It's important to know if our mental health policy is disproportionately taking away the freedom of groups of people who have historically been oppressed."

### Access to Health Care

#### "Plans To Shut Hosp Ripped"

Community members and employees of St. Mary's Hospital in Central Brooklyn protested plans to close the facility, said the June 7, 2005, **New York Daily News**. Various elected officials and members of the clergy were also in attendance at the rally, which was coordinated by NYLPI Community Organizer Anthony Feliciano. In

a letter to the State Health Commissioner quoted in the article, Senior Staff Attorney Amanda Masters wrote, "Patients will not be adequately served without this hospital. No closure plan should be approved." For more on NYLPI's work on this important issue, see page 1.

### Environmental Justice

#### "New Fear At Bronx HS: Toxic Dust Spewed By Trucks"

The hard work of NYLPI Staff Attorney Janette Wipper and Community Organizer Larry Tilley was featured in the **New York Daily News** on May 24, 2005. The New Bronx Academy High School was built last year, over the objection of the community board and community groups organized by NYLPI, on a site of a former electronics factory that also served as a parking lot for the trucks that sprayed for West Nile virus. Tests have found pollutants in the soil and water that far exceed acceptable state standards. Janette described the city's testing of the soil as "more about liability than actual health risks."

## Dechert Attorneys Fight to Save Home of Disabled Clients

Last summer, NYLPI searched for a *pro bono* attorney to help create a constructive trust for the home of two siblings, one of whom is mentally retarded. Both siblings are in their 70s and had lived in the house since 1959. When their mother died, she deeded the home to another sibling, with the understanding that her two children living in the house could stay there.

Two attorneys at **Dechert** volunteered and have been tremendous advocates for their clients. Associate Itai Tsur, under the supervision of

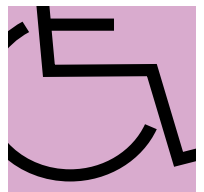
partner Robert Sparks, was able to secure a Temporary Restraining Order against the owner of the house, who was attempting to evict his brother and sister. Having survived a Motion to Dismiss, the legal team is very optimistic about their chances of success later this summer when the case goes before the judge.

"My experience has been very positive, the responsibility has been great, and it is nice

to see the tangible benefits others are deriving (thus far) from our efforts," commented Itai Tsur.

In addition to being their long-time home, the house is well-located for the siblings. One is able to walk to a senior citizens center, and the space is familiar and able to accommodate both of their needs. Hopefully, with the aid of their *pro bono* attorneys, they will be able to remain in their home.

"I've been practicing law for a long time, and I like *pro bono* cases," remarked Robert Sparks. "It is nice to give something back by representing people in need; I find it very, very rewarding."

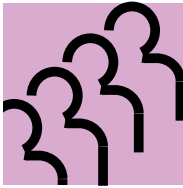

# In-House Update

## The Disability Law Center

**The De-Institutionalization of People with Developmental Disabilities:** NYLPI continues to work with Coler/Goldwater Specialty Hospital and Nursing Facility and other nursing homes to ensure that residents with developmental disabilities have access to appropriate care, programs and services, and fresh air. We are working on both systemic and individual levels and our advocacy and negotiations are ongoing. For example, on a systemic level, in response to NYLPI's efforts, Coler staff have now implemented a monitoring system to track how often residents go outside to access fresh air. On an individual level, NYLPI was able to obtain a new high-tech wheelchair for a 16-year-old resident.

**The Placement of Children in Foster Care in Nursing Homes:** In response to NYLPI's advocacy efforts on behalf of foster children with disabilities, the Administration for Children's Services (ACS) has agreed to severely restrict placement of foster children in nursing homes and to issue a policy prohibiting placement in nursing homes unless they are the least restrictive and appropriate placement. Currently, NYLPI is working to get foster children moved from nursing homes such as the Bayview Nursing and Rehab Center in Long Island into more appropriate and less restrictive placements.

**Interagency Coordination on Behalf of Foster Children with Developmental Disabilities:** NYLPI is negotiating to participate in pending litigation brought by the City Administration for Children's Services against the State Office of Mental Retardation and Developmental Disabilities that relates to placements and services for children with developmental disabilities. In order to ensure that the interests of children are adequately represented in the suit, NYLPI staff is planning to intervene, with the goals of ensuring greater inter-agency coordination and the provision of appropriate services.

**Tom F. v. Board of Education:** This case involves the right of parents of children with disabilities to place their children in private schools at public expense if the public school system fails to provide a program that can meet their needs. Because of wide-spread deficiencies in the public special education system, numerous

parents, some with quite limited means, invoke this right as the only opportunity for their children to learn. In January, Judge Daniels of the United States District Court for the Southern District of New York issued a decision restricting this right to parents whose children had previously received special education services in public schools. The decision was appealed to the Second Circuit. NYLPI staff arranged for Patterson, Belknap, Webb & Tyler to represent the parent on appeal and also worked closely with Morrison & Foerster to submit an *amicus curiae* brief on behalf of thirteen organizations serving low-income children with disabilities.

**Direct Services and The Matter of M.:** NYLPI represents M., a 50-year-old man who is deaf and has mental illness, who was living on his own in an apartment that was being paid for by his 97-year-old aunt. M.'s family called NYLPI with the concern that he could not live in his own apartment because he had never learned the skills to live independently. M.'s family came to realize that he needed a supportive living arrangement that would provide him with a safe, healthy, and socially stimulating environment, but needed assistance finding an appropriate placement. NYLPI's advocates met with M. and his family members and worked with them to find a placement in an independent living arrangement called The Tanya Towers Treatment Apartment program, licensed by the Office of Mental Health. M. moved into his own apartment in April, 2005, and, so far, is doing well. He is doing his own laundry, showering every day, and spending time with his peers.

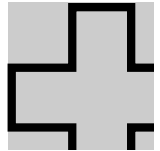
## Access to Health Care

**Committee to Save Our Hospitals:** NYLPI staff has been working intensely with the Committee to prevent the loss of needed medical services in Central Brooklyn. See pages 1 and 5 for more information.

**The Immigrant Health Access and Advocacy Collaborative of the New York Immigration Coalition:** Building on its relationship with the New York Immigration Coalition (NYIC), NYLPI began participating in NYIC's Immigrant Health Access and Advocacy Collaborative, providing technical assistance on language access issues to community groups, including: Haitian-Americans United for Progress, Korean Community Services of Metropolitan New York, the Latin American Integration Center, Make the Road by Walking, and others.

**MediSys:** NYLPI, co-counsel from the Legal Aid Society, and community groups from the New York Immigration Coalition filed what may be the first civil rights complaint against a hospital network for failure to provide language

assistance services. The complaint, filed with the New York Attorney General, alleged that the MediSys network — including Brookdale Hospital Medical Center, Flushing Hospital Medical Center and Jamaica Hospital — fails to provide people who are limited English proficient with adequate translation and interpretation services. The Attorney General has accepted the complaint and is investigating.

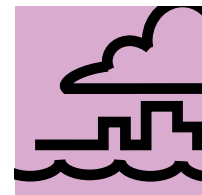


**New York Presbyterian Hospital:** NYLPI is also negotiating with New York-Presbyterian about its language assistance policy on behalf of a broad coalition of community groups led by Alianza Dominicana, Make the Road by Walking, Mirabal Sisters Community & Cultural Center, the New York Civic Participation Project, and local community leaders.

**Brooklyn Hospital:** NYLPI is monitoring compliance with the language assistance agreement that was negotiated last year with Brooklyn Hospital.

## Environmental Justice and Community Development

**Solid Waste:** NYLPI has been advocating for an equitable solid waste management system for many years. Approximately eighty percent of the City's garbage is currently handled in three neighborhoods in sub-standard transfer stations that import and export by truck over 30,000 tons of garbage every day. These neighborhoods also bear the burden of the heavy truck traffic and diesel emissions associated with these land-based transfer stations. As part of its work on behalf of these overburdened communities, NYLPI continues to work to secure an economic, environmentally sound, and equitable solid waste management plan equally protective of all New Yorkers. Announced by the Mayor at the end of 2004, a new plan is being finalized by the City. NYLPI has been actively working with local executive agencies, legislative officials, and others to ensure this new plan provides environmental justice for communities of color overburdened by land-based transfer stations.



**"Toxic High" in Soundview:** NYLPI has been working with the Concerned Residents Committee in Soundview, raising questions about contamination on the former site of Loral Electronics Systems, where the Soundview Educational Campus, a public high school, is

now located. NYLPI's staff helped to organize a community forum on May 19, 2005, in which community leaders, federal, state and local elected officials, and representatives of the School Construction Authority (SCA) all participated. At the forum, SCA was presented with the findings and recommendations of an independent engineer working with the community. NYLPI's efforts have included investigation of legal strategies, organizing, media work, factual investigation, and negotiations. On May 24, 2005, the New York City Department of Buildings declared Loral's abandoned manufacturing building located 200 yards away from the school an "immediate emergency" and ordered that the building be demolished. On May 31, 2005, the New York City Department of Environmental Protection ordered the current owners of the site to remove all the municipal solid waste tractor-trailers parked next to the school from the site.
